If someone else serves as the Class Representative, then I designate the Class Representative(s) as my agents to make decisions on my behalf concerning the litigation, the method and manner of conducting the litigation, the entering of an agreement with the Plaintiffs’ counsel concerning attorneys’ fees and costs, and all other matters pertaining to this lawsuit.
5. I authorize the law firm and attorneys at Barrett Johnston & Barkan Meizlish to use this consent to file my claim in a separate lawsuit, class/collective action, or arbitration against the company.
6. I authorize the law firm and attorneys at Barrett Johnston and Barkan Meizlish to communicate with me via text, email, and fax at their discretion.
